Nursing Pathway Options

The nursing program has three pathways outlined below:

The **Traditional Pathway** is the primary educational pathway for most OCCC nursing students. This pathway admits students each fall and spring semesters. This option is designed to be completed in 5 semesters. Once selected for admission into the nursing program, the traditional pathway is comprised of 4 semesters of core nursing courses. This pathway requires nursing courses to be taken one at a time in a specific sequence.

- **Fall cohort** – Classes are on campus (face-to-face) and meet 2 times a week. There are two sections for enrollment; mornings from 9:00 a.m. – 12:00 p.m. or 1:00 p.m.-4:00 p.m.; lab and clinicals are mandatory with varying times/dates.
- **Spring cohort** – Classes are on campus (face-to-face) and meet 2 times a week. There are two sections for enrollment; from 5:30 p.m. – 8:30 p.m. or 1:00 p.m.- 4:00 p.m.; lab and clinicals are mandatory with varying times/dates.

The **Career Ladder Pathway (CLP)** admits students in the spring semester and is designed for individuals with an unencumbered LPN, paramedic, or certified anesthesia technologist (CerTT) license. Once selected for admission into the nursing program, the CLP pathway is comprised of 2 semesters including 1 summer. The CLP pathway requires nursing courses to be taken one at a time in a specific sequence.

- **Spring entry only** –This course is a hybrid course design with class delivered in an online format. Exams and mandatory labs are on campus on Tuesdays with dates/times varying from 9:00 a.m. – 7:00 p.m. throughout the program. There are no clinicals for the Nursing Role Transitions NUR1413 course. Nursing Process III and Nursing Process IV have in-person clinicals with varying dates/times.

Once a student successfully completes the CLP Role Transition (NUR1413) course, they are eligible to apply for Credit for Prior Learning. Up to 15 credit hours for LPN and paramedic experience may be awarded.

The **Baccalaureate to Associate Degree Nurse Accelerated Pathway (BADNAP)** admits students in the fall with a baccalaureate degree or higher in a discipline other than nursing from a regionally accredited institution of higher education. Once selected for admission into the nursing program, the BADNAP pathway is compressed into 10 months. BADNAP is a hybrid course format designed for individuals who have completed a Bachelor's, Master's, or Doctoral degree.

- **Fall entry only** - class meets 1 day each week on Thursdays from 9:00 a.m. – 4:00 p.m. in addition to online class work; lab and clinicals are mandatory with varying times/dates. Labs are typically an additional one day a week and clinical is typically an additional two days per week, including weekends.

Basic Application Requirements

Traditional Nursing Pathway Information

All Traditional applicants must meet the basic requirements listed below:

1. Admission to Oklahoma City Community College (Prior to the nursing application deadline).

Criteria for admission to Oklahoma City Community College may be found in the College Catalog. If it has been more than 12 months since a student has taken courses at OCCC, the student may need to re-apply to the college.

2. Completion of Prerequisite Courses: (These courses must be completed with a grade of “C” or higher by the start of NUR 1519) ENGL 1113 English Composition I; PSY 1113 Introduction to Psychology; BIO 1023 Introduction To Nutrition; BIO 1314 Human Anatomy & Physiology I; CHEM 1123 Survey of General, Organic, and Biochemistry AND CHEM 1131 Laboratory for Survey of General, Organic, and Biochemistry OR CHEM 1115 General Chemistry I. (Students who have not yet completed these course must upload proof of enrollment in the course(s) by the application deadline). NOTE: Please meet with a Health Professions academic advisor to make sure all transfer coursework is equivalent.

3. College Retention Grade Point Average (GPA)..... **Minimum 2.5000** (Undergraduate GPA)

The College Retention GPA must include a minimum of 12 credit hours earned at an accredited institution in 1000-level or above science, math, social science, or English courses excluding credit awarded by advanced standing. It will include all coursework attempted with the exception of courses forgiven through the Repeat, Reprieve, or Renewal provisions as outlined in the College Catalog. Students who wish to request academic forgiveness must submit a petition to the Office of Records and Graduation Services prior to the application deadline.

4. Accuplacer Next-Gen Reading placement test score..... **Minimum Score of 250**

Reading scores are accepted two (2) years from the application deadline. Students who wish to raise their Reading scores should visit with an advisor from the Office of Student Success Advising about retesting guidelines. (Substitutions are not accepted.)

Selection Process – Once basic application requirements are met, students are ranked by the highest number of preference points. After ranking by preference points, students are then ranked by the highest undergraduate retention GPA.

Career Ladder Pathway (CLP)

LPN's, Paramedics, & CerTT Only

All Career Ladder Pathway applicants must meet the basic requirements listed below:

1. The Admission to Oklahoma City Community College (Prior to the nursing application deadline). Criteria for admission to Oklahoma City Community College may be found in the College Catalog. If it has been more than 12 months since a student has taken courses at OCCC, the student may need to reapply to the college.

2. Unencumbered LPN, paramedic, or certified anesthesia technologist (CerTT) license.

3. Completion of prerequisite courses (These courses must be completed with a grade of "C" or higher by the start of NUR 1413) CHEM 1123 Survey of General, Organic and Biochemistry AND CHEM 1131 Laboratory for Survey of General, Organic and Biochemistry OR CHEM 1115 General Chemistry; BIO 1023 Introduction to Nutrition; BIO 1314 Human Anatomy and Physiology I; BIO 1414 Human Anatomy and Physiology II; PSY 1113 General Psychology; ENGL1113 English Composition I; ENGL1213 English Composition II. (Students who have not yet completed these course(s) must upload proof of enrollment in the course(s) by the application deadline). NOTE: Please meet with a Health Professions academic advisor to make sure all transfer coursework is equivalent.

4. College Retention Grade Point Average (GPA).....Minimum 2.5000 (Undergraduate GPA)

The College Retention GPA must include a minimum of 12 credit hours earned at an accredited institution in 1000-level or above science, math, social science, or English courses, excluding credit awarded by advanced standing. It will include all coursework attempted with the exception of courses forgiven through the Repeat, Reprieve, or Renewal provisions as outlined in the College Catalog. Students who wish to request academic forgiveness must submit a petition to the Office of Records and Graduation Services prior to the application deadline.

5. Accuplacer Next-Gen Reading placement test score.....Minimum Score of 250

Baccalaureate to Associate Degree Accelerated Pathway (BADNAP)

All BADNAP applicants must meet the basic requirements listed below:

1. Admission to Oklahoma City Community College (Prior to the nursing application deadline)

Criteria for admission to Oklahoma City Community College may be found in the College Catalog. If it has been more than 12 months since a student has taken courses at OCCC, the student may need to reapply to the college.

2. Bachelor's degree or higher from an accredited institution.

A student must submit an official transcript from an accredited institution **with the degree posted**. (Students who have not yet earned their Baccalaureate Degree but will complete their degree by the start of NUR 1519, must upload a certified letter from their current institution indicating that they are expected to graduate by the start of NUR 1519).

3. Completion of Prerequisite Courses: Successful completion of all general education and support requirements with a grade of "C" or higher (Exception of POLSC 1113 and HIST 1483 or HIST 1493, in which a grade of "D" is minimum) PRIOR to the start of NUR 1519. The general education and support requirements are: PSY 1113, ENGL 1113, ENGL 1213, HIST 1483 or HIST 1493, POLSC 1113, BIO 1023, BIO 1314, BIO 1414, BIO 2125 **or** BIO 2124, CHEM 1123 and CHEM 1131 or CHEM 1115. (Students who have not yet completed these course(s) must upload proof of enrollment in the course(s) by the application deadline). NOTE: Please meet with a Health Professions academic advisor to make sure all transfer coursework is equivalent.

4. College Retention Grade Point Average (GPA)..... Minimum 2.5000 (Undergraduate GPA)

The College Retention GPA includes all coursework attempted with the exception of courses forgiven through the Repeat, Reprieve, or Renewal provisions as outlined in the Oklahoma City Community College Catalog. Students who wish to request academic forgiveness must submit a petition to the Office of Records and Graduation Services prior to the application deadline.

5. Course Completion

All general education and support coursework (including the approval of any course substitutions) must be successfully completed prior to the start of NUR 1519. (Students who have not yet completed these courses must provide proof of enrollment in the course(s) by the application deadline.)

Selection Process –Students are ranked according to highest GPA (undergraduate only). Students are placed in two tiers. Students in the top tier are selected before the lower tier.

- Top Tier - those who have completed a minimum of a Bachelor's degree and all required prerequisite courses prior to the application deadline. Bachelor's degree from an accredited university must be conferred on official transcript.
- Lower Tier – those who are 'in progress' to complete a Bachelor's degree or required prerequisite course(s) by the application deadline.

Preference Points

Once the basic application requirements are met, applicants may improve their opportunity for selection by earning preference points. A maximum of 29 total preference points may be awarded from three categories:

Nursing Program Requirements

1. Tuition and Program Costs (see enclosed Estimated Costs for the Nursing Program)

All students seeking financial aid should contact the Student Financial Support Services office at OCCC (405-682-7527) as early as possible, indicating the program option for which you are applying. 2. Grade Requirements

To progress in the nursing program, the student must achieve a “C” (a passing score of 74% or greater) as defined in each nursing course syllabus.

3. NESAs Clinical Requirements

All students must view the required Nursing Educators and Service Administrators (NESA) videos and pass the NESA exam, with a score of 85%, annually prior to attending clinical rotations. This will be explained in detail at the orientation.

4. Clinical Management Platform

The clinical management platform (CMP) is a web-based platform to facilitate the cooperative scheduling, coordination, and arrangement of clinical rotation schedules to provide opportunities among hospitals, schools, and students.

Information available on the CMP includes the student's weekly clinical assignment, clinical requirements, and facility orientation materials. The student is **required** to create an account and will receive login instructions and platform access via their OCCC email. This account will be accessible to coordinators, staff, and administrators (who have access to the Website) at your school and at the various hospitals where you are scheduled for clinical rotations.

5. Computer Requirements

Steps for Successful Application

Admission to Oklahoma City Community College

1. **Apply to OCCC** at <http://www.occc.edu/onlineapplication/>.

Applicants who have attended OCCC in the past may need to reapply to the college.

2. **Schedule an appointment with Health Professions Student Success Advisor:**

Advising offices are located in the main building across from the OCCC campus Bookstore and Admissions. Students may request an appointment by calling **405- 682-7849**. The Student Success Advisor will help with enrolling in classes, provide you information on the nursing application process, review your transcripts, and advise about pending coursework and issues regarding GPA, etc.

4. **Make sure all coursework from other institutions will transfer.** Please meet with a Health Professions academic advisor to make sure all transfer coursework is equivalent.

5. **Make sure all pre-requisite courses are complete or in-progress prior to applying to the nursing program. In-progress pre-requisite courses must be completed before starting the nursing program.**

6. **Submit your nursing application online.**

7. **All Nursing applications include a \$30.00 application fee** and must be submitted online with official documents uploaded, via the application link posted on the nursing webpage

Oklahoma Board of Nursing Information for NCLEX

Graduates of this state-approved program are eligible to apply to write the National Council Licensure Examination (NCLEX) for registered nurses. Applicants for Oklahoma licensure must meet all state and federal requirements to hold an Oklahoma license to practice nursing. In addition to completing a state- approved nursing education program that meets educational requirements and successfully passing the licensure examination, requirements include submission of an application for licensure, a criminal history records search including fingerprinting, and evidence of citizenship or qualified alien status [59 O.S. §§567.5 & 567.6]. To be granted a license, an applicant must have the legal right to be in the United States (United States Code Chapter 8, Section 1621). In addition, Oklahoma law only allows a license to be issued to U.S. citizens, U.S. nationals, and legal permanent resident aliens. Other qualified aliens may be issued a temporary license that is valid until the expiration of their visa status, or if there is no expiration date, for one year. Applicants who are qualified aliens must present to the Board office, in person, valid documentary evidence of:

1. A valid, unexpired immigrant or nonimmigrant visa status for admission into the United States;
2. A pending or approved application for asylum in the United States;
3. Admission into the United States in refugee status;
4. A pending or approved application for temporary protected status in the United States;
5. Approved deferred action status; or
6. A pending application for adjustment of status to legal permanent resident status or conditional resident status.

The Board has the authority to deny a license, recognition or certificate; issue a license, recognition or certificate with conditions and/or an administrative penalty; or to issue and otherwise discipline a license,

recognition or certificate to an individual with a history of criminal background, disciplinary action on any professional or occupational license or certification, or judicial declaration of mental incompetence [59 O.S. §567.8]. These cases are considered on an individual basis at the time application for licensure is made. Potential applicants to state- approved education programs, with a criminal history, may obtain a determination of eligibility for licensure or certification from the Oklahoma Board of Nursing for a fee. Clinical Requirements

This document provides a brief overview of key requirements for prospective nursing students at Oklahoma City Community College (OCCC). For complete and current details, please refer to the official OCCC Nursing Student Handbook available online at www.occc.edu/health/nursing. Requirements are subject to change, and students are responsible for checking the most up-to-date information.

1. Background Check:

- Nationwide background report required
- Includes OSBI searches for sex offender, violent offender, and criminal history
- Student is responsible for the cost
- Clinical agencies review and can accept or deny access
- Any break in enrollment requires a new background check

2. Drug Testing:

- Required for all students before first clinical assignment
- Must produce a negative result to remain in the program
- Medical marijuana is not accepted, even if legal in Oklahoma
- Positive test results in loss of eligibility

3. CPR Certification:

- American Heart Association Basic Life Support (BLS) Healthcare Provider CPR required
- Must be current for the entire semester
- Online training is acceptable only if it includes in-person skill check-off

4. Student Liability Insurance:

- Required for all students in clinical courses
- Must be renewed annually

5. Immunizations:

- TB test (QuantiFERON Gold Blood Test or Two-Step TB skin test)
- MMR (2 vaccinations or positive titer)

- Varicella (2 vaccinations or positive titer)
- Hepatitis B (3-dose series, 2-dose Heplisav-B, or positive titer)
- TDAP (within last 10 years)
- Annual Influenza vaccine or waiver
- COVID-19 vaccine (annual) or waiver

6. Important Notes:

- All requirements must remain current throughout the semester
- Clinical site policies may vary and are subject to change
- Declination waiver for some vaccines may be accepted but could limit clinical placements
- Students with nursing licenses or AUA certification must be unencumbered
- Nursing students are responsible for all their individual compliance costs
