**\*ENHANCED ADVANCED STANDING & PRIOR LEARNING ASSESSMENT**  
**at Southern Nazarene University**

The balance of credit hours required to graduate with a bachelor's degree after OCCC transcribed coursework and SNU transcribed major coursework is typically earned through SNU's Enhanced Advanced Standing and/or Prior Learning Assessment programs.

Eligible transferring learners may petition up to 9 credit hours of certifications, licenses, or other professional development prior to beginning SNU major coursework through SNU's Enhanced Advanced Standing program. Also, transferring learners may petition up to 30 credit hours of Prior Learning Assessment through additional professional development and/or Life Learning Papers. Petitioning for Enhanced Advanced Standing and/or Prior Learning Assessment for potential university credit is not guaranteed.

Enhanced Advanced Standing petitions are for potential Elective credits only, while select Prior Learning Assessment petitions may be considered to fulfill either General Education and/or Elective needs.

Example: OCCC transferring learner has 60 OCCC college credit hours; the learner petitions for 9 SNU credit hours through Enhanced Advanced Standing and 15 SNU credit hours through Prior Learning Assessment; the learner completes 36 credit hours in the SNU major:  $60 + 9 + 15 + 36 = 120$  credit hours required for SNU bachelor's graduation.

*Credits earned through SNU's Enhanced Advanced Standing and Prior Learning Assessment programs are free of charge to current SNU learners.*
